New VisionsHYBRIDGE: Law

NV^H: Law, offered in partnership with SUNY Schenectady, provides high school seniors with an introduction to careers in law. This honors-level program is designed to introduce students to the content and skills needed in several in-demand legal fields. Throughout the year, students will develop critical thinking, oral and written communication, creativity, innovation, collaboration, problem-solving, cultural literacy, and interpersonal skills, preparing them for success in the legal profession.

This hybrid program combines asynchronous college coursework with hands-on work-based learning experiences. Students will explore foundational legal concepts and gain practical experience in the legal field.

This program includes the first three courses of SUNY Schenectady's Paralegal two-year A.A.S. program and is designed for students aiming to transfer to a two year paralegal program or a longer educational pathway terminating in a career as an attorney. Nearly two-thirds of the coursework in the program is focused on core legal specialties, offering a strong academic foundation in law.
